- Video-link solemnisation will become a permanent option:
  - $\Box$  for couples where at least one is a Singapore Citizen or Permanent Resident; and
  - □ where both parties are physically present in Singapore.

## DIVORCE BY MUTUAL AGREEMENT OF THE IRRETRIEVABLE BREAKDOWN OF THE MARRIAGE (DMA)

- Couples may cite this fact after at least 3 years of marriage, if they mutually agree on the divorce, and are required to submit to the court:
  - □ Reasons leading them to conclude that their marriage has irretrievably broken down
  - □ Efforts made to reconcile; and
  - □ Considerations surrounding post-divorce arrangements for:
    - □ children (especially); and
    - □ financial affairs



## DIVORCE SUPPORT PROGRAMMES & PROGRAMME FOR CHILDREN

- MÀ
- All divorcing parents with minor children to attend the Mandatory Parenting Programme (MPP) before they can file for divorce.
- Court is empowered to advise:
  - □ key related persons (e.g. grandparents) to participate in programmes; and
  - □ minor children to participate in the Programme for Children, if deemed beneficial.

#### **ENFORCEMENT OF CHILD ACCESS ORDERS**

- Provide a range of measures, including therapeutic interventions, to enforce child access
  - □ Parent Education
  - □ Co-mediation
  - □ Specialist Therapeutic Interventions
  - □ Family Support Programme
  - □ Compensation of Time and Expense
  - □ Performance Bond or Security
  - □ Imprisonment or Fines
